The San Antonio Mid-Year Meeting

The Homeland Security Committee, chaired by Alan Brodsky, presented its final report. Much time, restructuring, and modification has shaped this committee into one that can meet the timely responsibilities now approaching. Both of these committee chairmen are retiring from their tenures in June.

Local Chapter Meeting at Sturbridge on February 6th

The joint meeting with the Western Massachusetts Industrial Hygiene Association went off splendidly, with cooperative weather and a great turnout. We encouraged the Connecticut chapter to attend and four CT members from our neighbor state to the south were present. The speaker was Sal DiNardi, Ph.D., a professor at Umass-Amherst who is a certified Industrial Hygienist, Chairman of the Environmental Health Department *and* Program Director of the Industrial Hygiene Program at the university. His topic was monitoring devices for indoor air on submarines. He traced the history of the monitoring devices to what is presently applicable.

If you register then decide to cancel, you must do so before April 4th, or you are responsible for payment.


